FORM TO DECLARE THE CHOICE OF

REGISTRATION REFUND OPTIONS (Declaration Form)

Option A: For every paid participant of EUROMATH & EUROSCIENCE 2020 there will be a registration coupon issued that can be used in the conference 2021. This coupon can be transferable to other students or teachers and will have the value of the registration paid in 2020. Participants in 2021 who choose option A, WILL NOT have to pay the new registration fee of 2021 or its difference, which will be higher, since the conference in 2021 in one day longer. This increased difference is expected to be up to 30 euro. So accepting the coupon is equivalent to full refund plus additional save of up to 30 euro for next year.

Option B: If paid participants prefer to receive a refund of the 2020 registration fee now, the organizers decided to pay the full refund even though they had real expenses and even though the programme and abstracts publication is completed and published with ISBN. A full refund will be given minus an administration fee of 20 euro per participants and a shared bank expense for the bank transfer, if this occurs. Bank expense will be subtracted before refund is made. Note that choosing Option B, those attending the 2021 conference will have to pay again the registration fee, which as explained in Option A will be higher.
